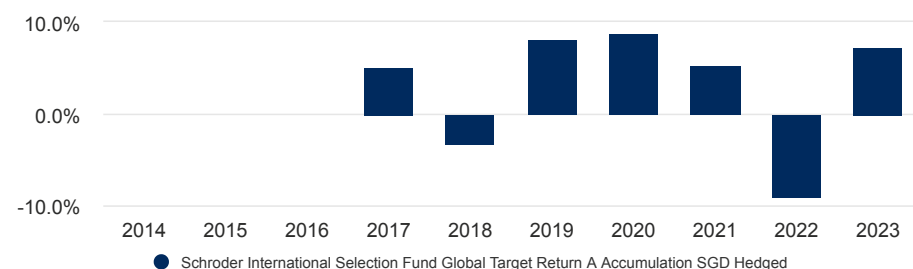

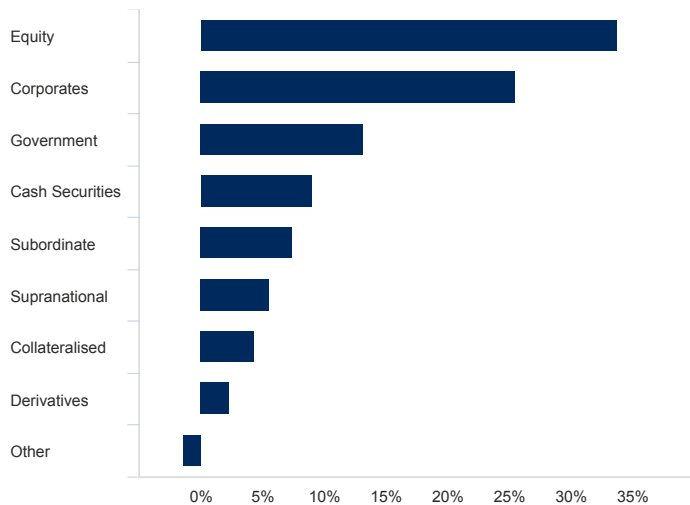

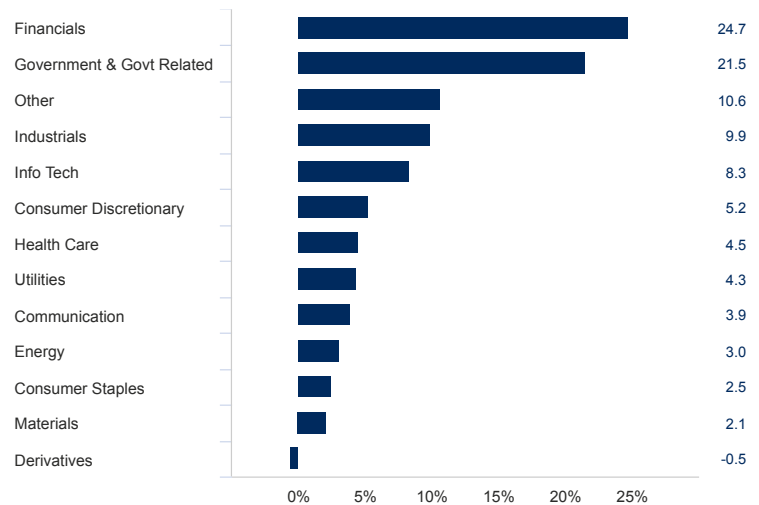

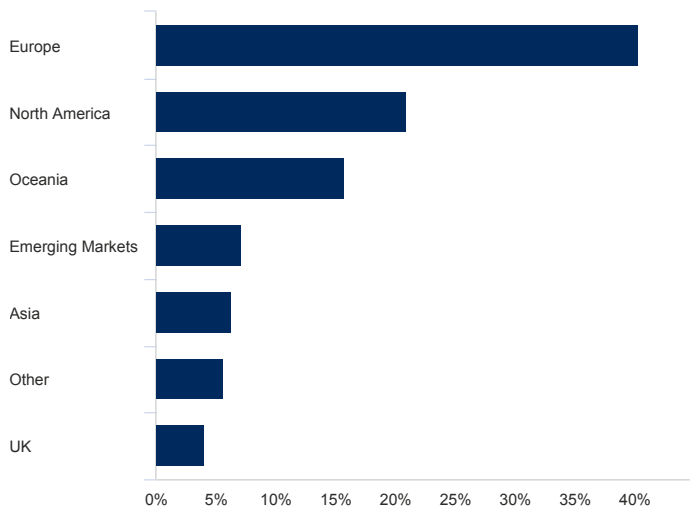
Asset class (%)



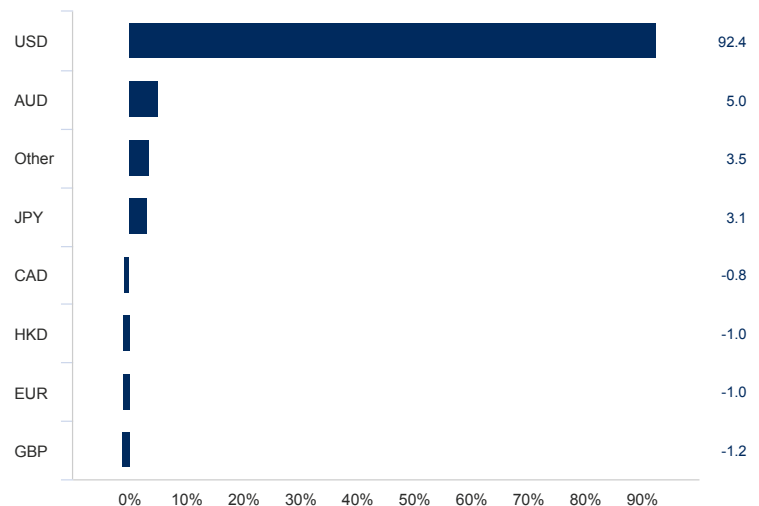
