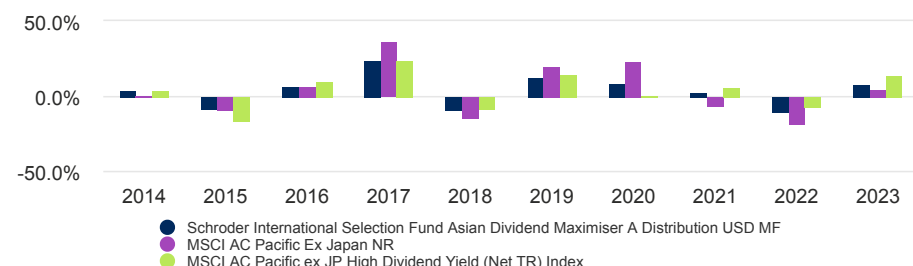

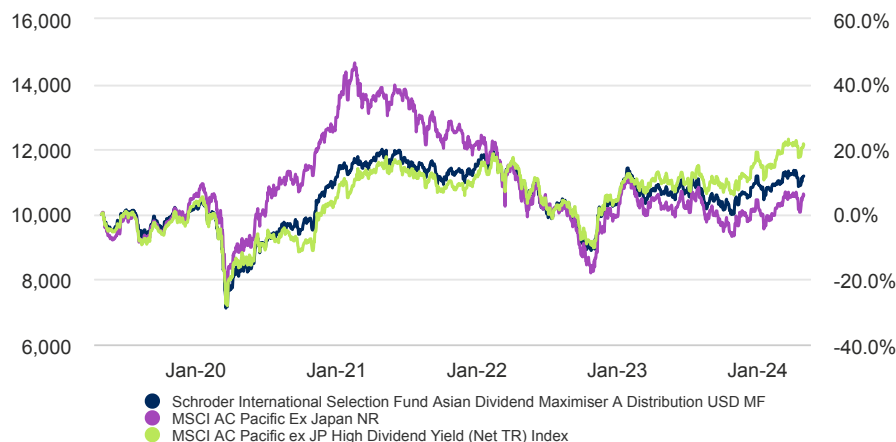

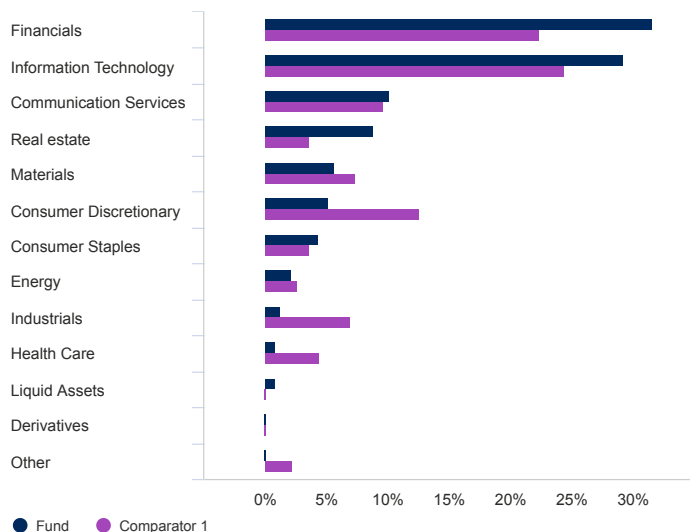

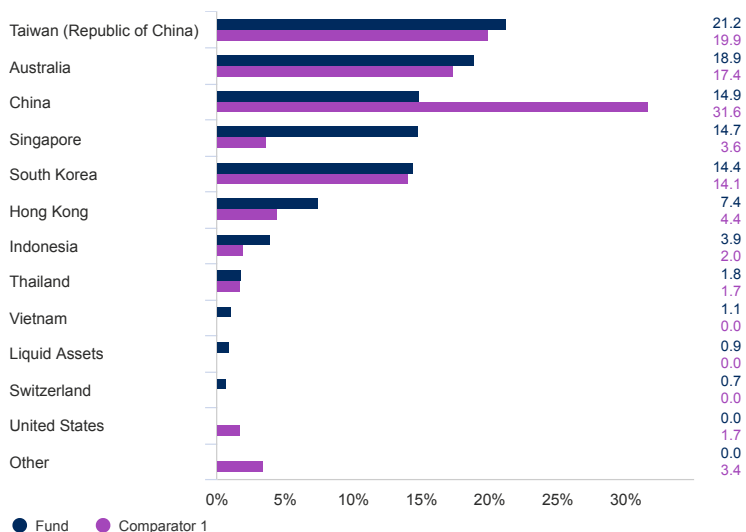

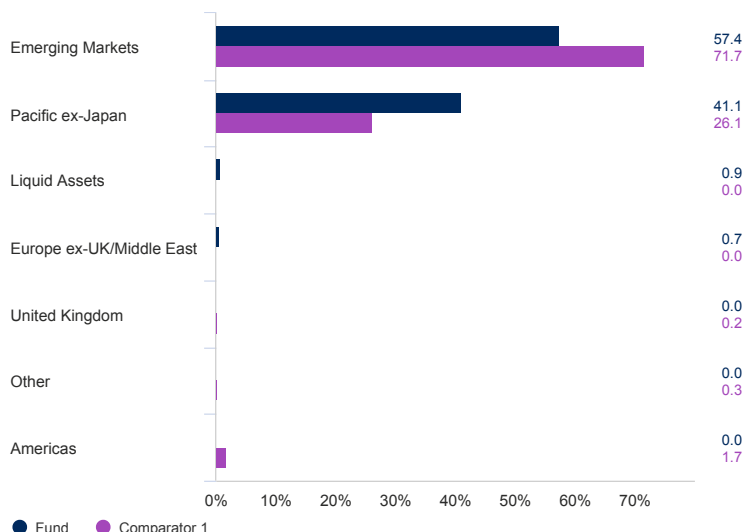
Sector (%)
