Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of shares worldwide.

Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 90% in shares of companies of any size that are based in, or carry out the larger part of their business activities in, both developed markets and emerging markets. The Fund seeks a portfolio volatility which is lower than that of the MSCI All Country World Index. The Fund uses a quantitative multi-factor investment process to identify stocks from a universe of investable shares, and ranks them from the least attractive to most attractive based upon certain factors, such as value, quality, momentum, low risk and size. The process makes use of proprietary systematic, defensive portfolio construction techniques aiming to maximize risk-adjusted return whilst reducing volatility and drawdowns during period of market turbulence. The Fund can invest up to 20% in China A and China B-shares. For China A-shares, up to 10% through the Shanghai-Hong Kong Stock Connect and/or the Shenzhen-Hong Kong Stock Connect, and up to 10% in CAAPs. The Fund may invest up to 10% in a combination of participation notes and convertible securities, and up to 10% each in securities issued or guaranteed by single sovereign issuers with a non-investment grade rating, REITs and other funds. 





Monthly performance commentary

Market Review

Global stock markets rose for a fifth consecutive month in March, as economic data remained broadly consistent with a soft-landing scenario. Risk appetite was also buoyed by central bankers eyeing a summer policy pivot. At a regional level, developed market equities maintained positive momentum amid optimism over the rate cut outlook in major economies. Many indices refreshed their all-time highs during the month. The US equity bull market continued, bolstered by high confidence in the soft landing, and leadership from quality growth. US core CPI inflation increased 0.4% month-on-month in February, the same rate as January. European equities also posted robust gains as Eurozone PMIs improved, hinting at a stabilisation in activity. UK equities increased as headline CPI inflation fell to 3.4% in February, from 4.0% in January. Equities in Asia Pacific ex Japan and Emerging Markets also advanced amid risk-on appetite, albeit to a lesser extent than major developed market regions, as investors remained cautious about the economic outlook in mainland China.

Factor Performance

In March, as of month-end, global alpha style performance was slightly negative. Within alpha factors, the cyclical Value factor rebounded and outperformed as global interest rates were kept on hold in most major regions. This was followed by dynamic Industry Momentum factor which was relatively muted and underperformed slightly, followed by the defensive Quality factor which also finished below the line. While Low Risk was rewarded in the first half of the month, it reversed towards month end, finishing below the line overall as equity markets rose. Finally, the cyclical Size factor lagged behind throughout the month and finished as the laggard factor.

Fund Commentary

In March, as of month end the fund underperformed its market cap weighted index. Our exposure to Styles weighed on performance. On a portfolio level, our exposure to Value contributed to performance, while our exposures to Size, Low Risk, Quality and Industry Momentum weighed on performance.

Countries

On a country basis, our overweight allocations to Spain, United Kingdom and Japan contributed to performance. Conversely, our underweight exposures to United States and Sweden coupled with our overweight allocation to Hong Kong weighed on performance.

Stock Level

On a stock level basis, our overweight allocations to Banco Santander S.A., The Kroger Co and Dell Technologies Inco contributed to performance. Conversely, our underweight exposures to Nvidia Corp and Taiwan Semiconductor Manufacturing Company coupled with our overweight allocation to Zoetis Inco weighed on performance.

Annually distribution is 1; semi-annually distribution is 2; quarterly distribution is 4; monthly distribution is 12. The annualised dividend yield is calculated based on the dividend distribution on the relevant date with dividend reinvested, and may be higher or lower than the actual annual dividend yield.
