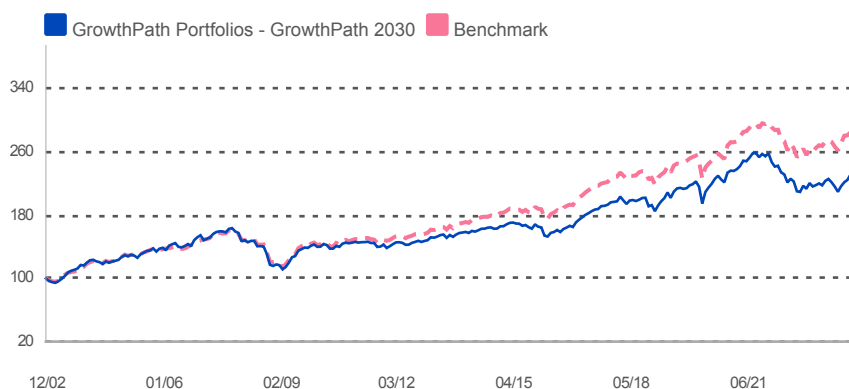


GrowthPath Portfolios - GrowthPath 2030

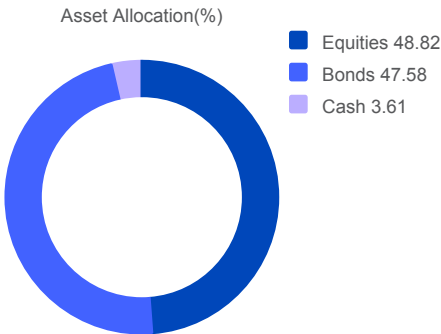
