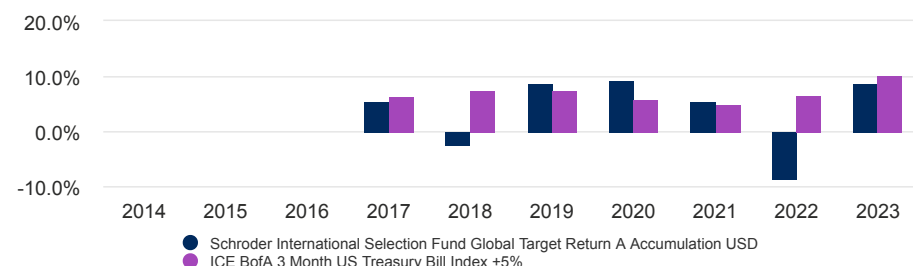

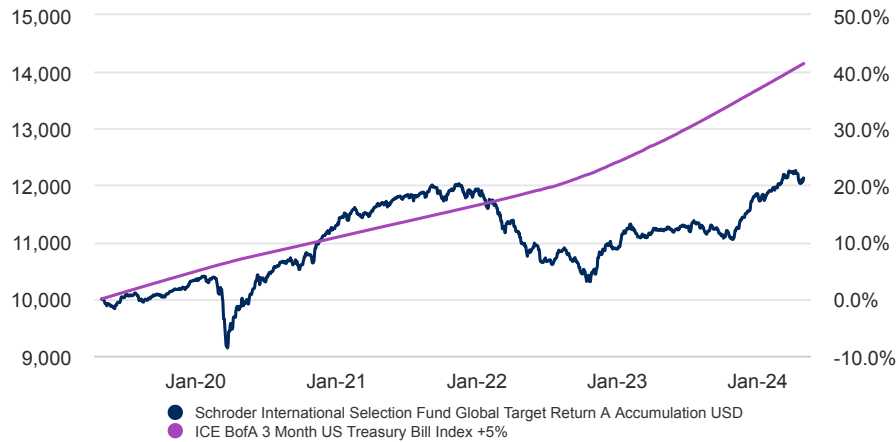

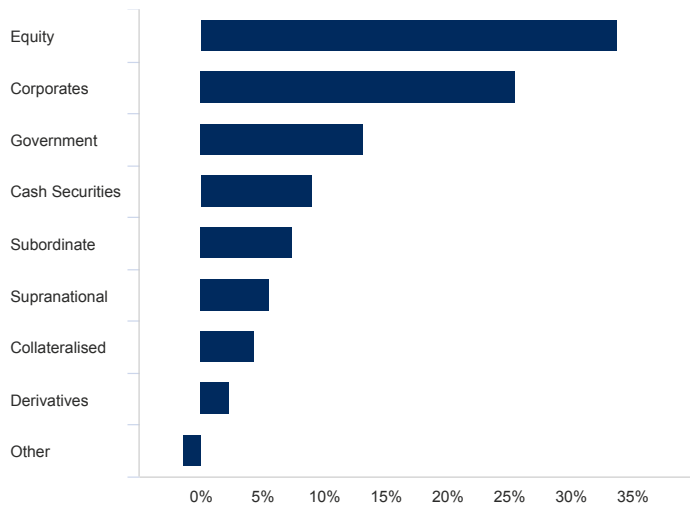

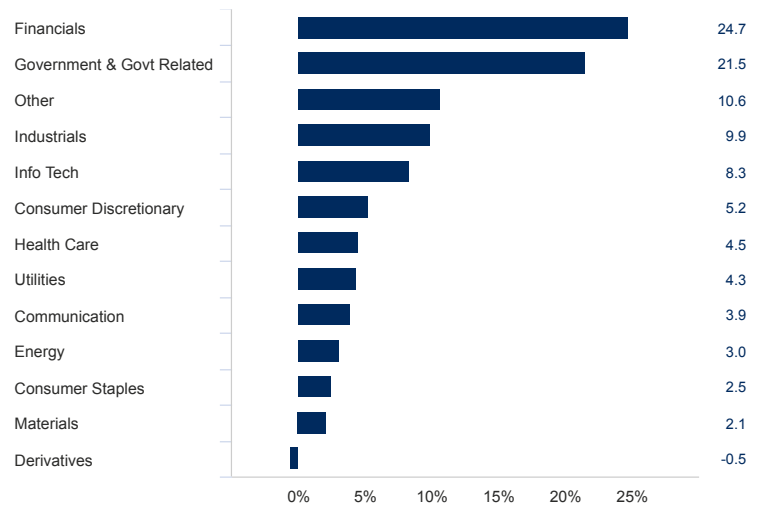
Asset allocation

Asset class (%)



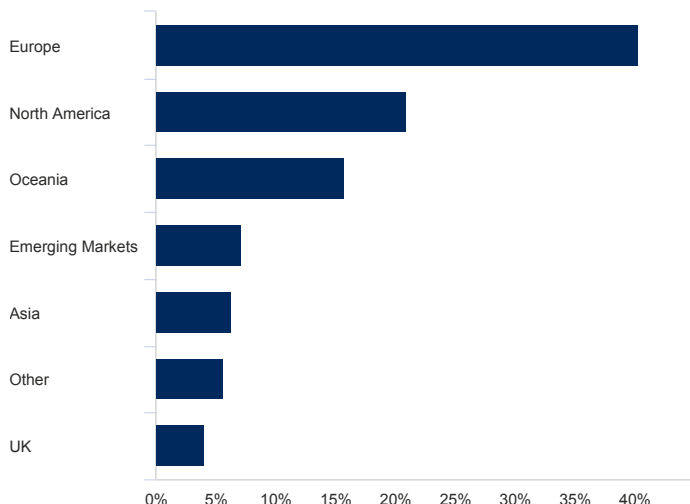

Sector (%)



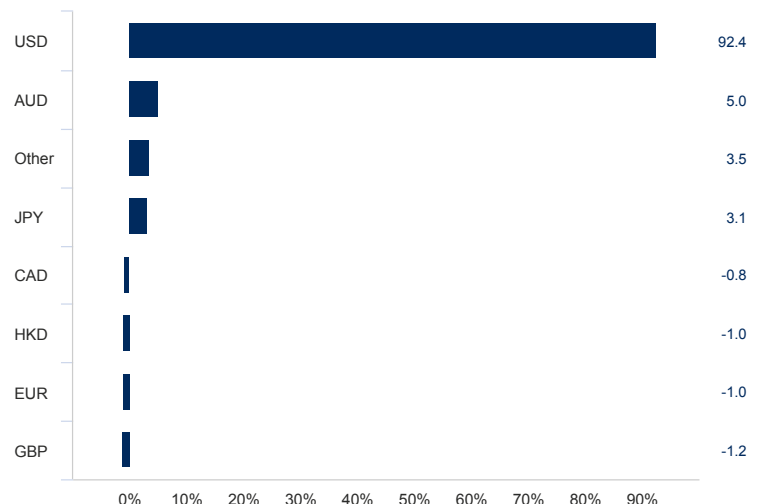
