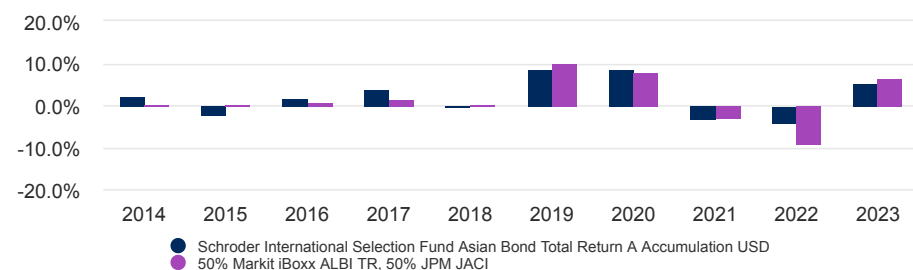

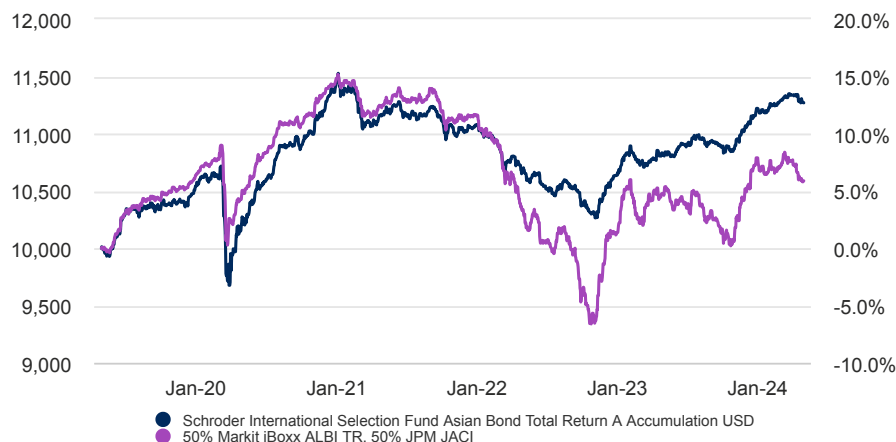

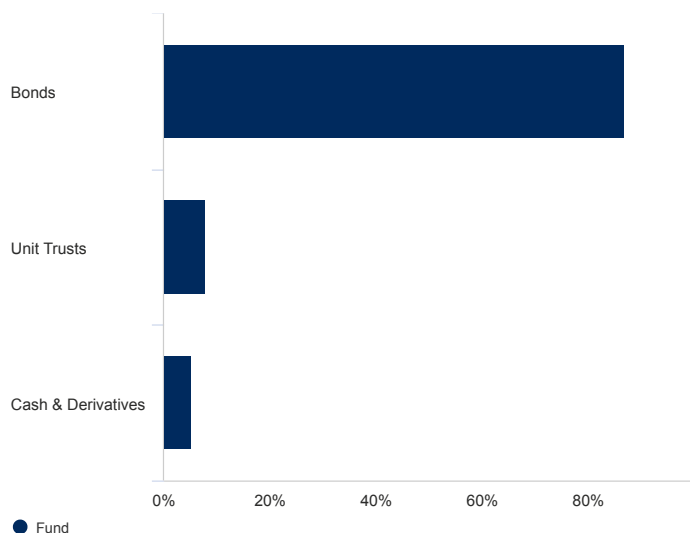

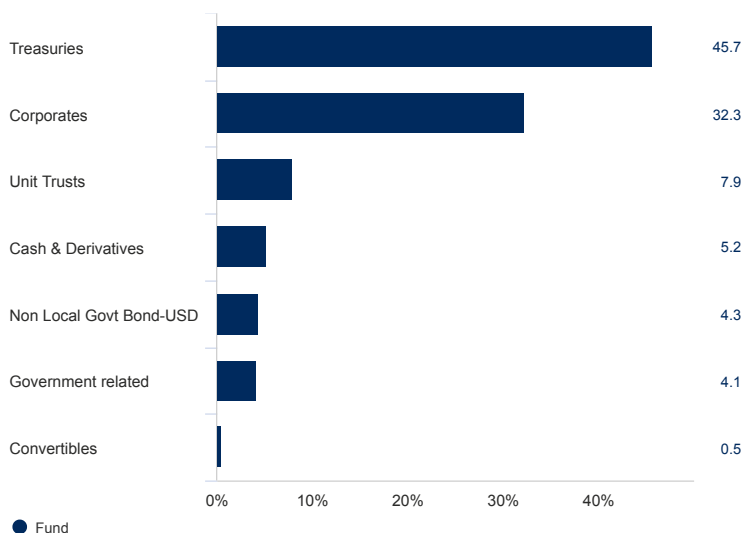

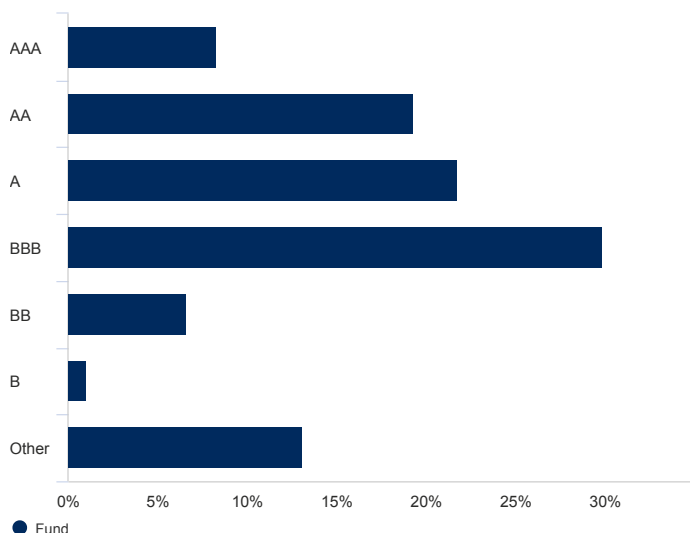
Asset class (%)



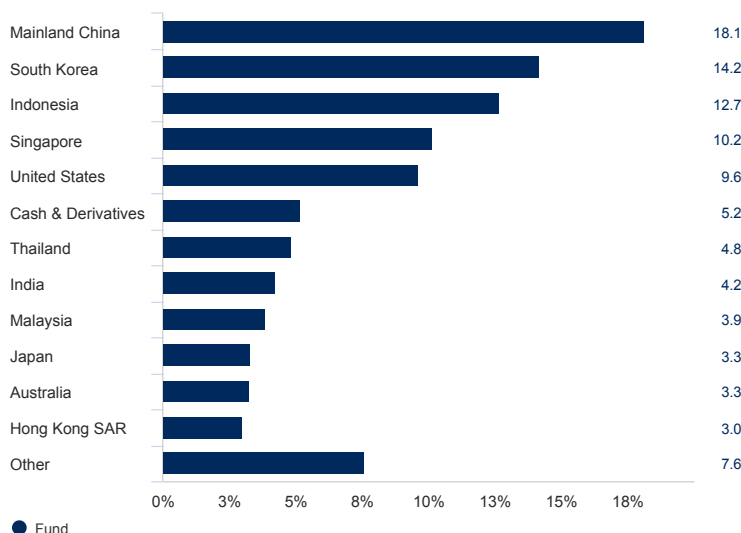
Sector (%)

Geographical breakdown (%)

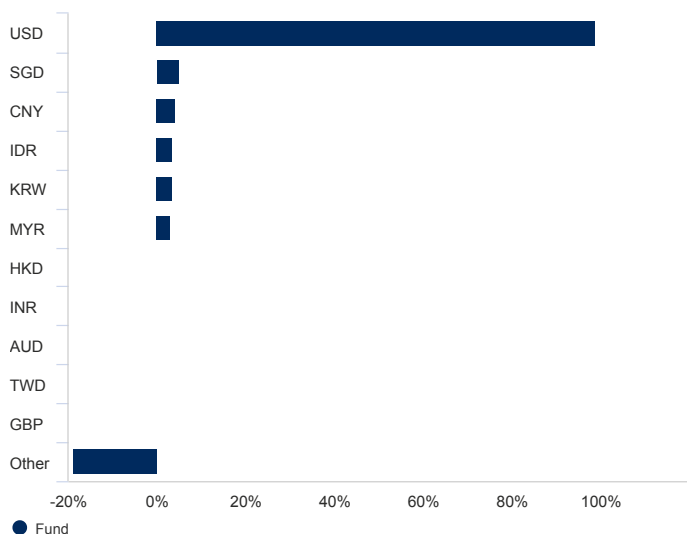
