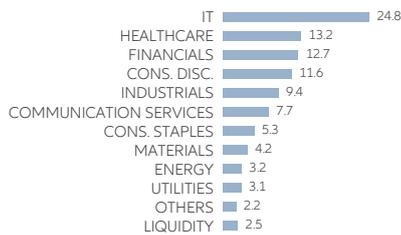

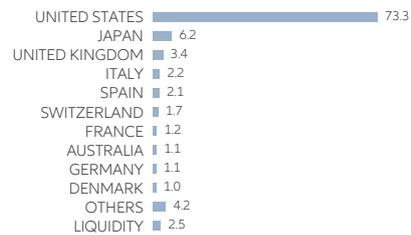

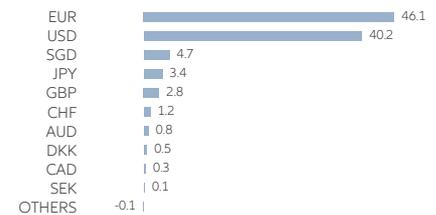
Sector Allocation (%)
