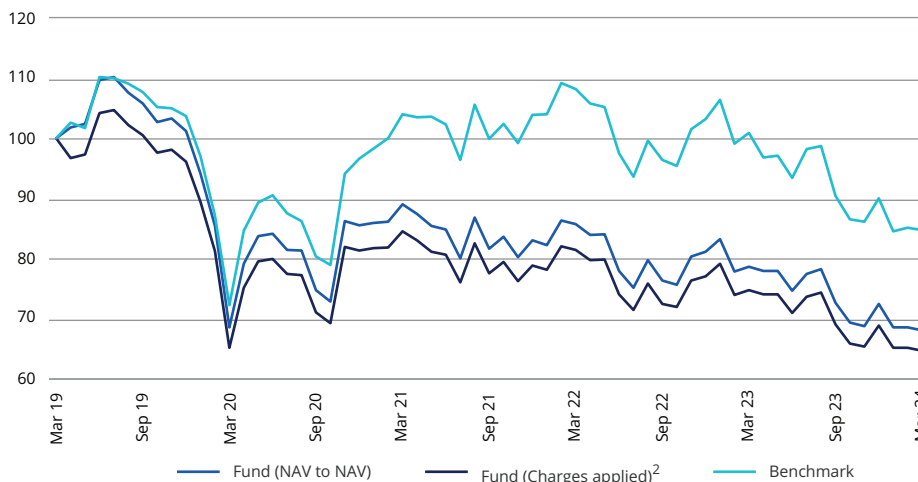
Objective
