The Portfolio seeks to increase the value of your investment over time through capital growth by typically investing in equity securities of companies in developed markets, as well as emerging markets, that the Investment Manager believes have lower volatility. These companies may be of any market capitalization and industry. The Investment Manager uses fundamental research and a proprietary quantitative risk/return model to select securities that appear to be high quality, to have low volatility and reasonable valuations and to offer attractive shareholder returns (bottom-up approach).

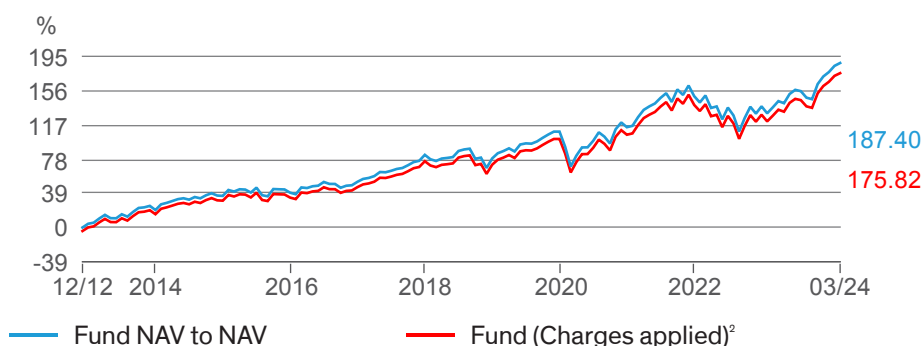
