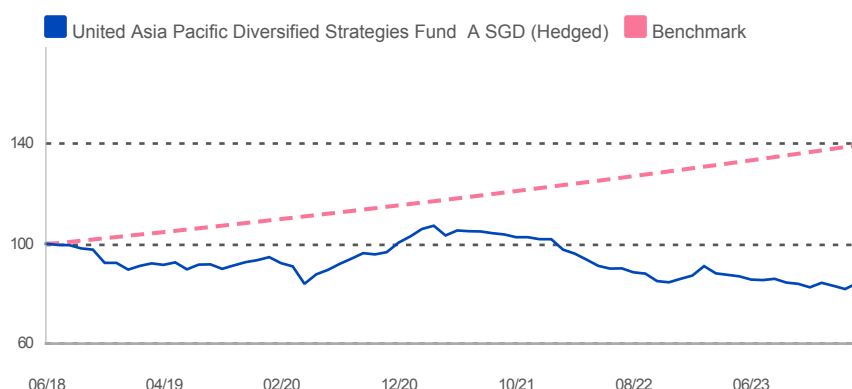


United Asia Pacific Diversified Strategies Fund

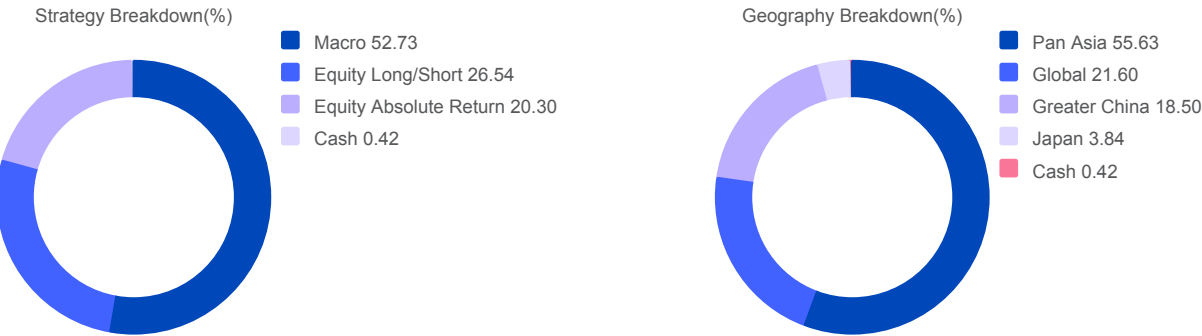

Top 3 Holdings

Fund 1 (Pan Asia Equity Absolute Return)	This is a long-biased Asia ex-Japan fund utilizing a combined approach of bottom-up research and macro inputs. Market risk is managed by shorts typically via index and cash management.
Fund 2 (Pan Asia Macro)	The fund is a Pan Asia focused discretionary macro strategy that adopts a top down approach in selecting and structuring investments in highly liquid instruments across multiple asset classes. It seeks to capitalize on discrepancies between global market perceptions versus local expectations.
Fund 3 (Greater China Equity Long/Short)	The fund adopts a Greater China Equity long/short strategy. It focuses on investing in the core assets of the Chinese economy with a preference for companies undergoing changes. This may include both structural or cyclical changes. The investment philosophy is fundamental in nature and the manger attempts to obtain an accurate valuation of the business.
