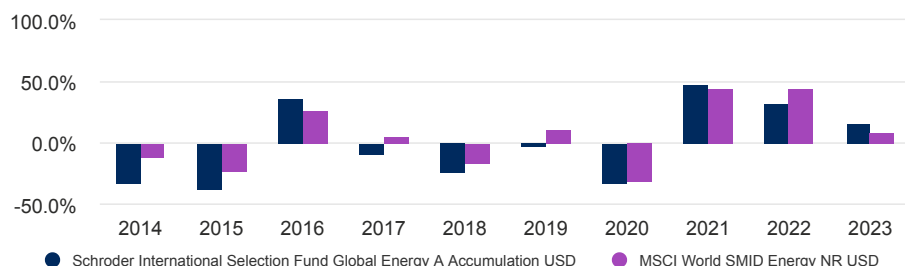

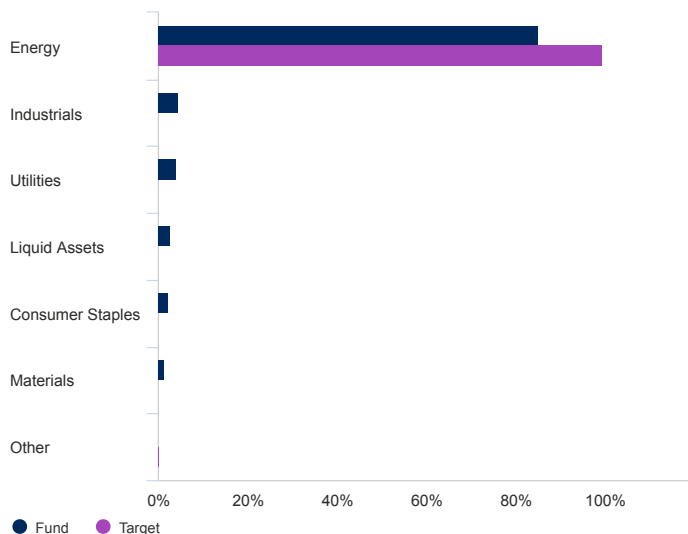

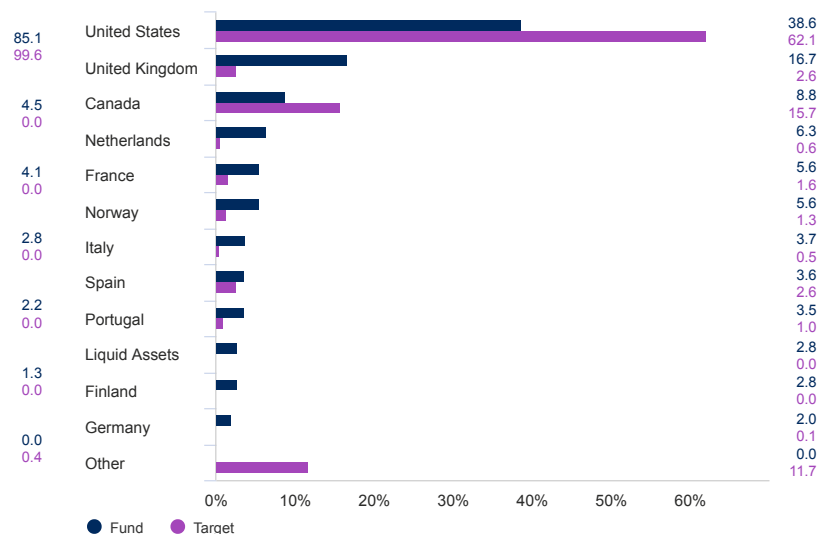

#### Geographical breakdown (%)

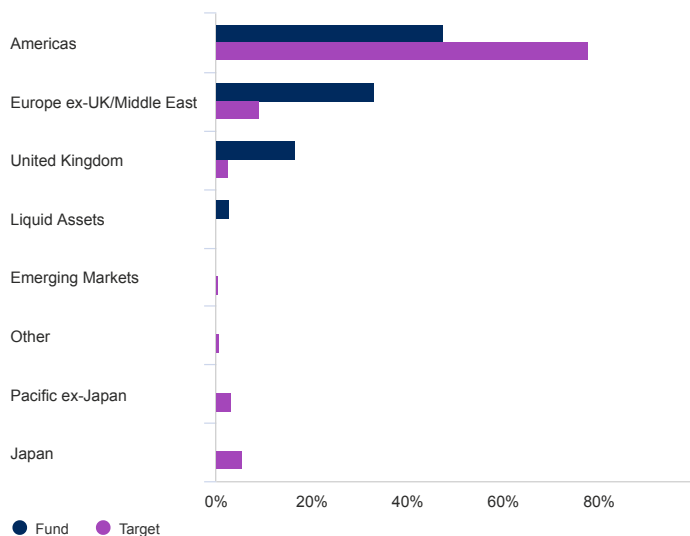
