
Objective

The abrdn Global Emerging Markets Fund aims to provide long-term capital gain by investing in emerging stock markets worldwide or companies with significant activities in emerging markets, or as a feeder fund to invest in the abrdn SICAV I - Emerging Markets Equity Fund (The "Underlying Fund"), a subfund of Luxembourg registered abrdn SICAV I. The Underlying Fund invests at least 70% of its assets in equities and equity related securities of companies listed, incorporated, or domiciled or do most of their business in Emerging Market countries. The Underlying Fund may invest up to 30% of its net assets in Mainland China equity and equity-related securities, although only up to 20% of its net assets may be invested directly through QFI regime, the Shanghai-Hong Kong and Shenzhen-Hong Kong Stock Connect programme or by any other available means.

The Underlying Fund aims to outperform the MSCI Emerging Markets Index (USD) benchmark before charges.
