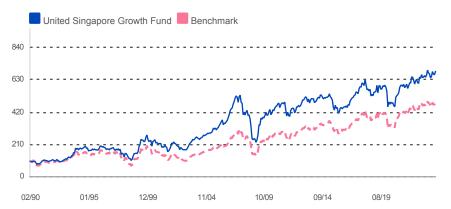


United Singapore Growth Fund

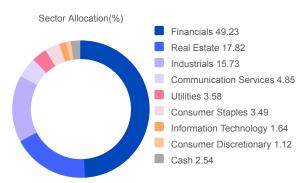


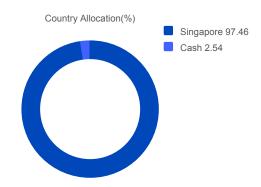
