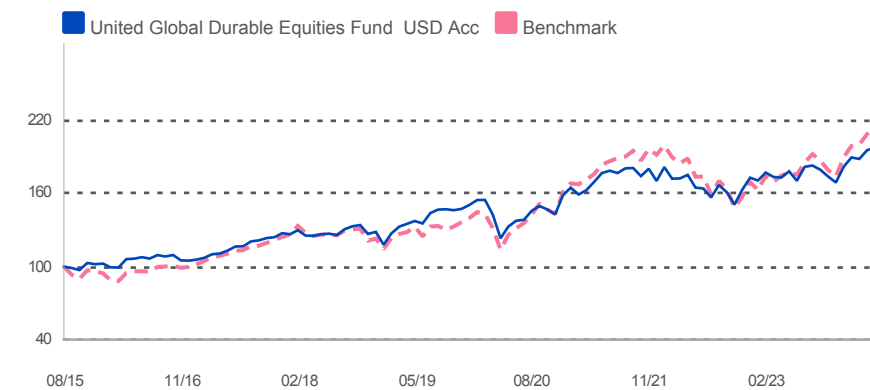


United Global Durable Equities Fund

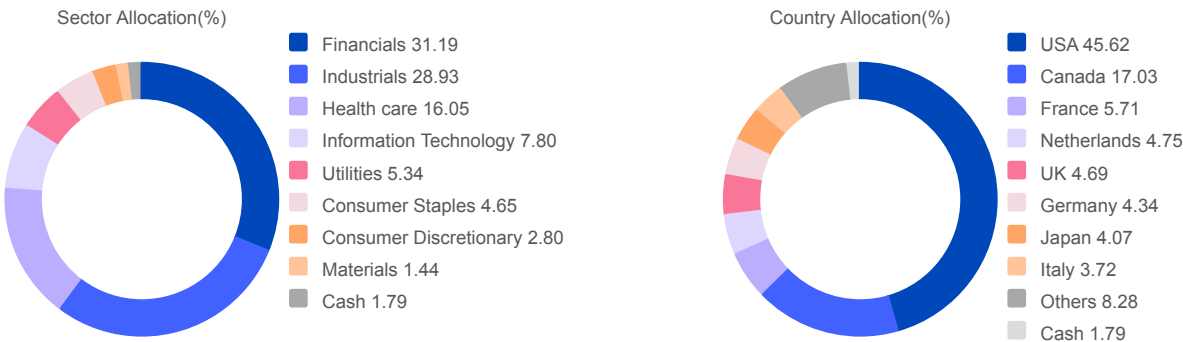
