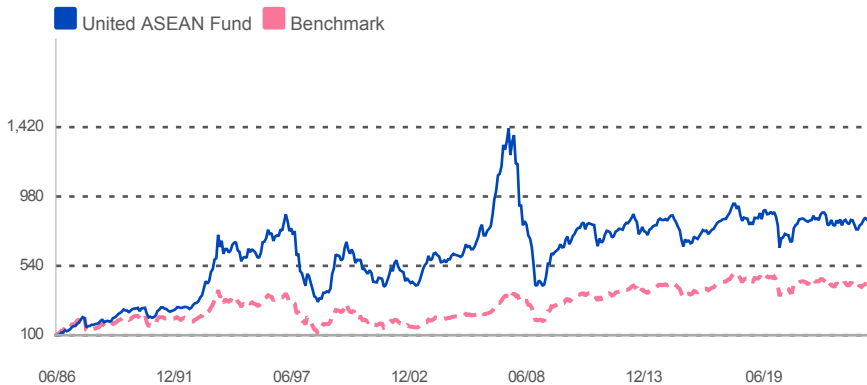


United ASEAN Fund

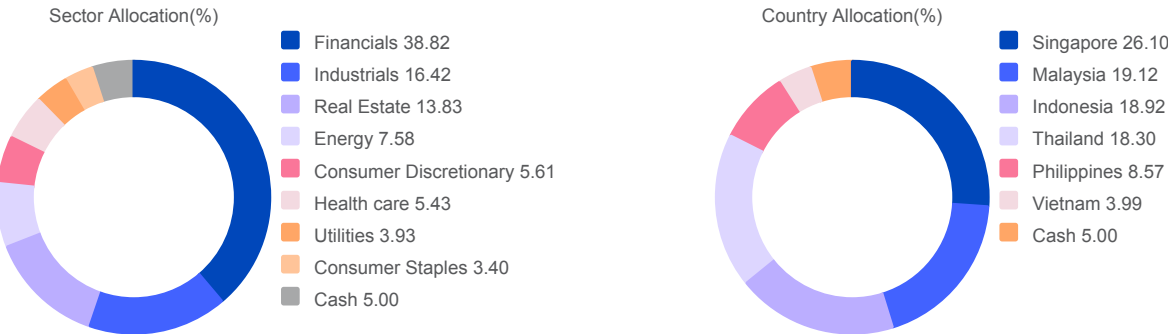
