<ul style="list-style-type: none"> • You are investing in a sub-fund of Natixis International Funds (Lux) I, an open-ended investment company organised as a société anonyme under the laws of Luxembourg and which qualifies as a société d'investissement à capital variable and a UCITS. • The sustainable investment objective of the Fund is to contribute to the protection of assets, data, goods and people's health while generating long-term growth of capital through an investment process systematically including ESG considerations. At least 90% of the Fund's net assets will be sustainable investments with a social objective. • The Management Company currently intends to make periodic distributions on the Class N1/D (USD), Class H-N1/D (GBP) and Class S1/D (USD) shares. Distributions will be made out of available net income, if any. In addition, the Board of Directors may declare interim dividends. The Management Company currently does not intend to make distributions on the other Classes.

Investment Strategy	
<ul style="list-style-type: none"> The Fund is actively managed and invests primarily in equity securities of companies around the world that have been identified by the Investment Manager as being participants in or having an exposure to the investment theme of Safety which is considered by the Investment Manager to be underpinned by secular growth trends. The Fund invests at least two-thirds of its total assets in equity securities worldwide, including up to 30% of its total assets in emerging markets companies including, but not limited to, certain eligible A-Shares via the Stock Connects. Investments in real estate investment trusts may not exceed 10% of the Fund's net assets. The Fund may invest up to one-third of its total assets in other types of securities than those described above as well as in money market instruments, cash and cash equivalents. On an ancillary basis, the Fund may also hold deposits at sight for up to 20% of its assets under normal markets circumstances. Contribution to the Fund's sustainable investment objective is assessed based on a sustainable thematic screening, as well as on a proprietary ESG assessment which relies, amongst others, on the ESG score of the securities. In addition, the Fund also applies exclusion criteria including inter alia, activity-based and behaviour based exclusions. Finally, the Fund has internally defined the implementation of an engagement process, which also encompasses the exercising of its voting rights. The combination of the different elements in this screening process allows to identify investment's contribution to the sustainable investment objective. The Investment Manager selects securities whose solutions contribute to the investment theme and meet the materiality or leadership requirement of the theme. The Investment Manager systematically excludes securities whose behaviour and overall performance are considered non-compliant to established global sustainability norms and principles governing corporate behaviour, in particular on environmental protection, human rights, labour rights, and business ethics. The Investment Manager further excludes securities that have exposure to harmful and controversial activities such as coal, conventional oil and gas, non-conventional weapons etc. The Fund is unconstrained by industry, index, currency, geographical considerations or capitalization size and the Investment Manager aims to invest in companies whose shares are selling below the Investment Manager's estimate of intrinsic value. HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?

- There is no cancellation period.
- You can redeem Shares by written request through an appointed Singapore distributor or by notifying the Registrar and Transfer Agent.
- Unless otherwise provided for in the Luxembourg Prospectus, the Registrar and Transfer Agent will usually pay the redemption proceeds within 3 full bank business days in Luxembourg on which the New York Stock Exchange and the NASDAQ are open from the date the relevant redemption request is deemed to be accepted. If the Local TA is used, it may take up to 5 full bank business days in Luxembourg on which the New York Stock Exchange and the NASDAQ are open for redemption payments to be processed locally.
- Your exit price is determined as follows:
 - Redemption requests received by the Registrar and Transfer Agent, either directly or through the Local TA, on or before the Dealing Deadline on a Dealing Day, will be accepted and processed on that day.
 - Redemption requests received by the Registrar and Transfer Agent, either directly or through the Local TA, as applicable, after the Dealing Deadline on a Dealing Day or on a day which is not a Dealing Day, will be accepted and processed on the next Dealing Day.
- The Local TA's dealing deadline is 5:00pm Singapore time on a Dealing Day.
- The redemption price that you will receive will be the NAV of the Share multiplied by the number of shares redeemed, less any applicable redemption charge. An example is as follows:

APPENDIX: GLOSSARY OF TERMS

- **“CDSC”** means contingent deferred sales charge.
- **“Dealing Deadline”** means 1:30 pm (Luxembourg time).
- **“Dealing Day”** means a business day in Singapore which is also a full bank business day in Luxembourg on which the New York Stock Exchange and the NASDAQ are open.
- **“ESG”** means Environmental, Social and Governance.
- **“Full bank business day”** means any day (other than a Saturday or Sunday) on which commercial banks are open for business for a full day in Luxembourg.
- **“NAV”** means the net asset value of the Fund or relevant Class.
- **“Singapore Representative”** means Natixis Investment Managers Singapore Limited.
- **“Stock Connects”** means the Shanghai-Hong Kong Stock Connect program and/or Shenzhen-Hong Kong Stock Connect program.
