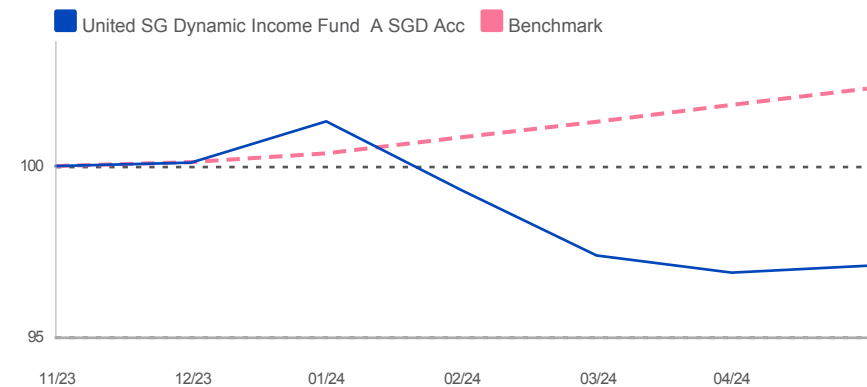


United SG Dynamic Income Fund
