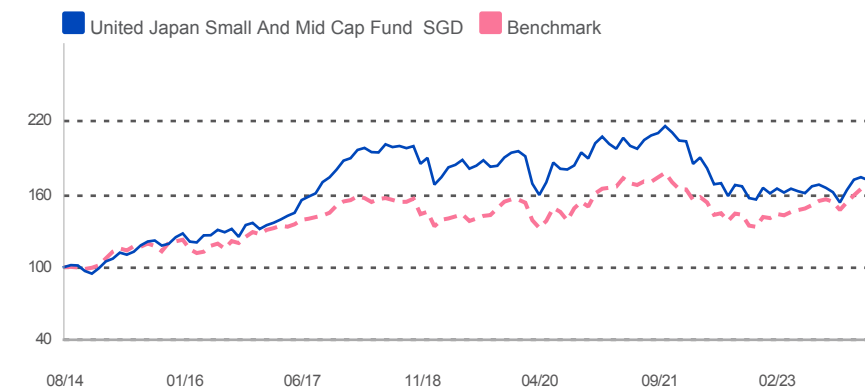


# United Japan Small And Mid Cap Fund

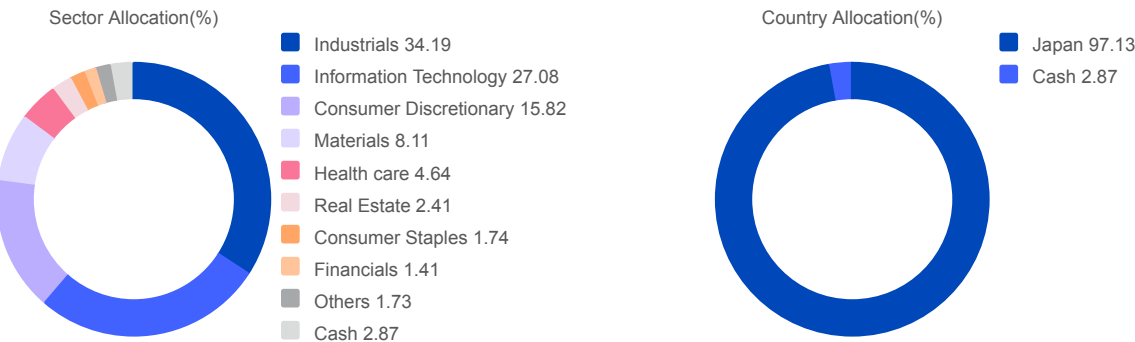
