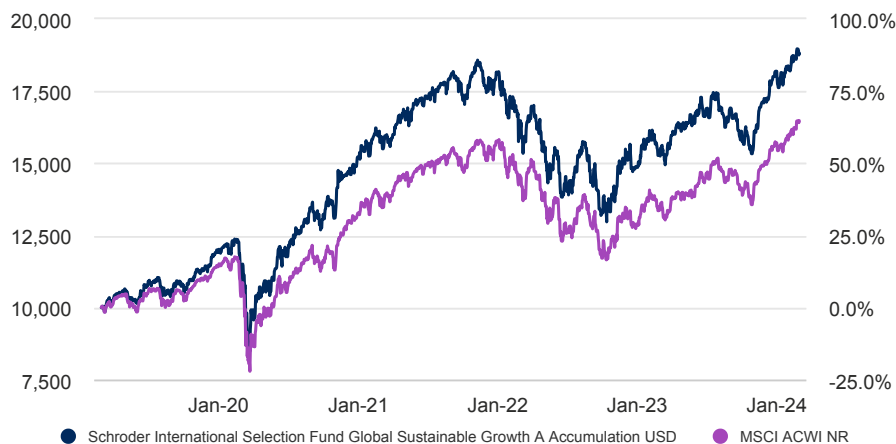

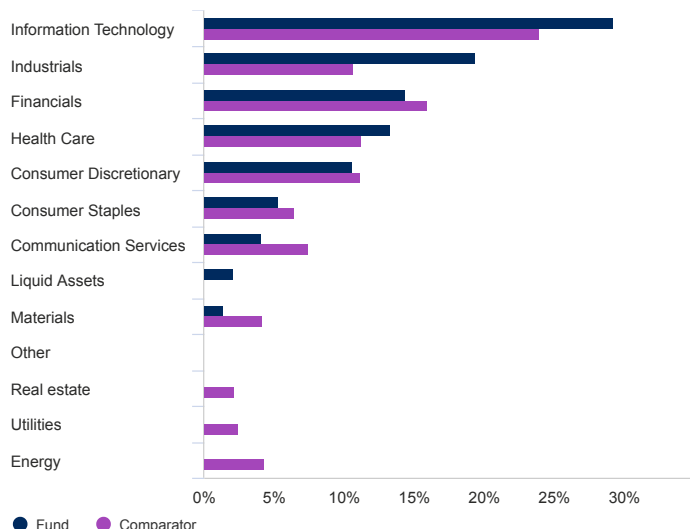

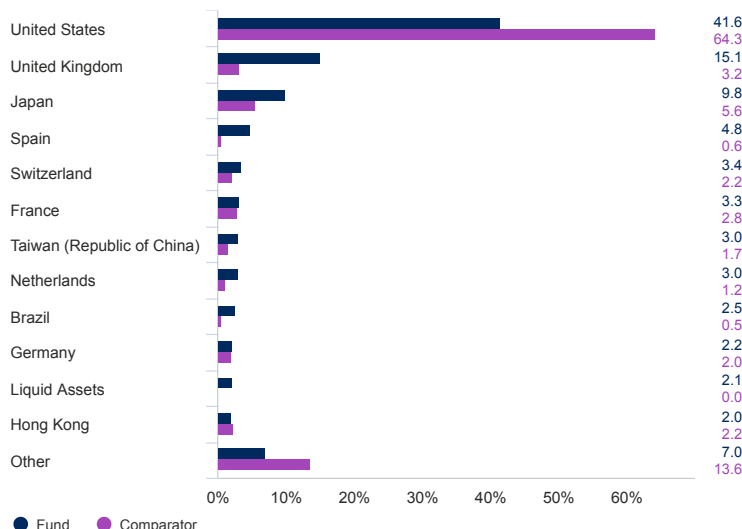

Geographical breakdown (%)

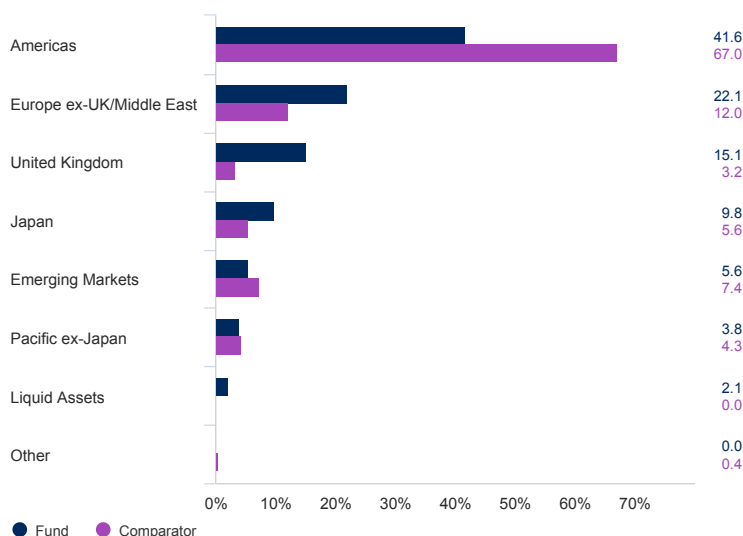
