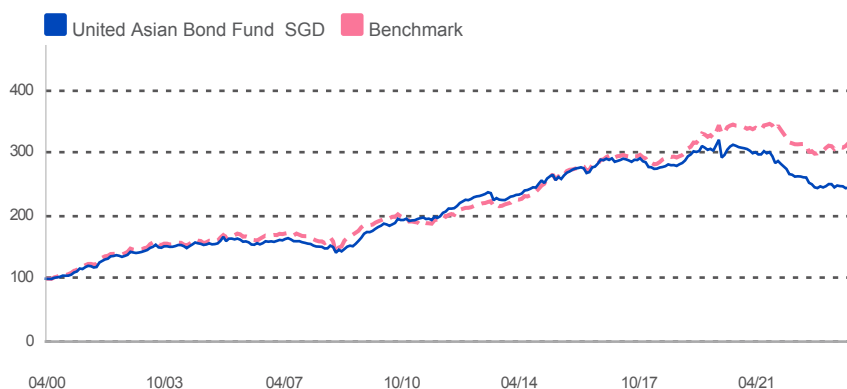


United Asian Bond Fund

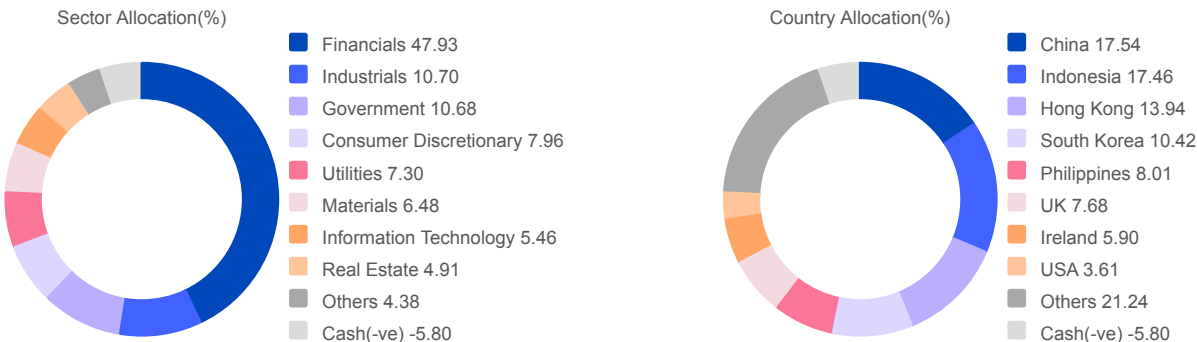
