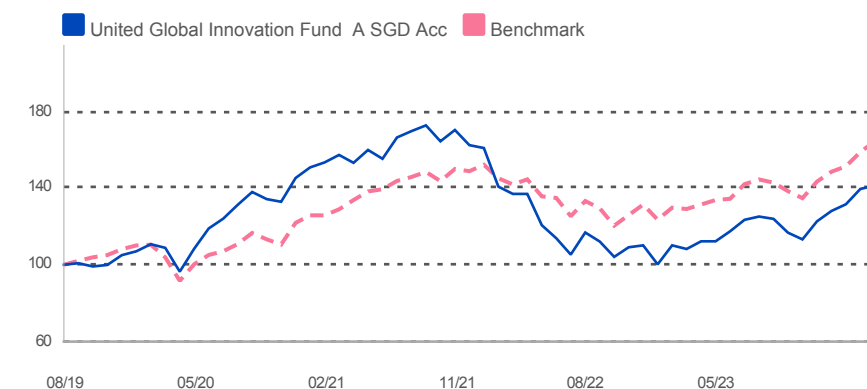


United Global Innovation Fund

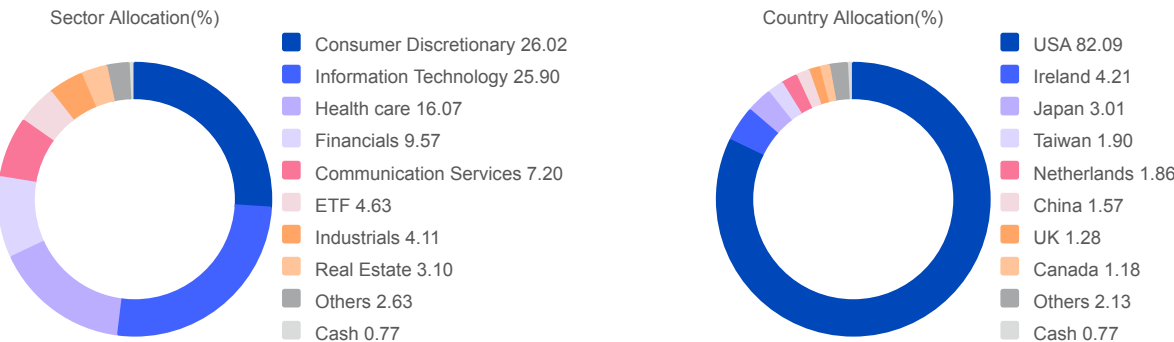
