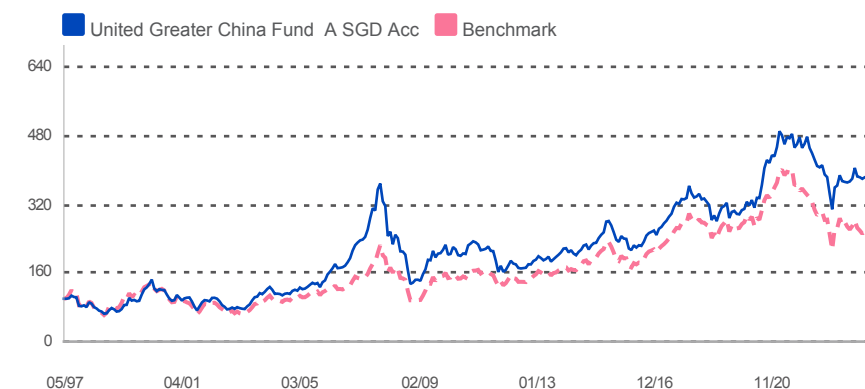


United Greater China Fund

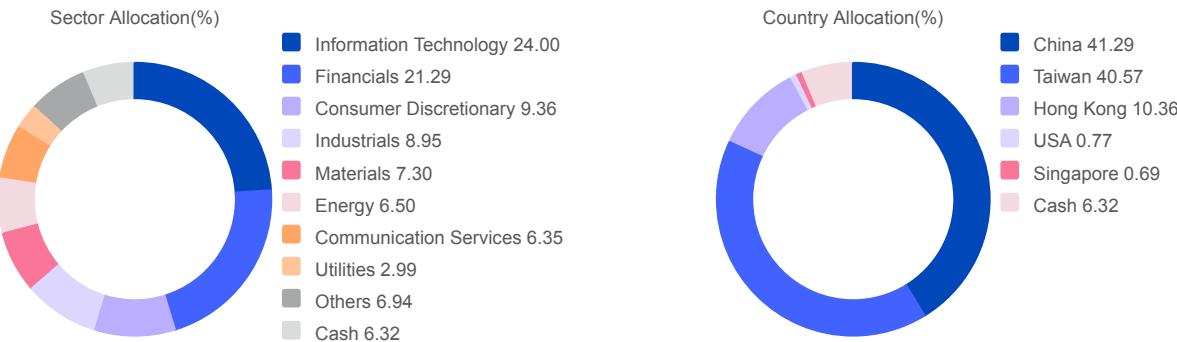
