<b>Investment Strategy</b>	
<b>STRATEGY</b> <ul style="list-style-type: none"> <li>The Portfolio invests in global equity portfolios that are designed as solutions for investors who seek equity returns but also want broad diversification of the related risks across styles, sectors and geographic regions. In managing the Portfolio, the Investment Manager efficiently diversifies between growth and value equity investment styles. The Investment Manager selects growth and value equity securities by drawing from a variety of its fundamental growth and value investment disciplines to produce a blended portfolio.</li> <li>Normally, the Investment Manager's targeted allocation for the Portfolios is an equal weighting of 50% growth stocks and 50% value stocks. The Investment Manager will allow the relative weightings of the Portfolio's growth and value components to vary in response to markets, but ordinarily only within a range of +/- 5% of the Portfolio. Beyond those ranges, the Investment Manager will generally rebalance the Portfolio toward the targeted allocation. However, under extraordinary circumstances, when the Investment Manager believes that conditions favoring one or the other investment are compelling, the range may expand to +/-10% of the Portfolio before rebalancing occurs.</li> <li>The Portfolio may use derivatives for EPM and hedging purposes.</li> </ul>	Refer to " <i>Investment Objective and Policies</i> " in the Prospectus relating to the Portfolio for further information on the investment strategy.

<b>Market and Credit Risks</b>	
<b>You are exposed to global Country Risks.</b> Investments in issuers located in a particular country or geographic region may have more market, political and economic risks because of particular factors affecting that country or region.  <b>You are exposed to Currency Risks.</b> Currency movements in the underlying investments of a portfolio that is denominated in a currency different from that of the portfolio itself may significantly affect the NAV of that portfolio.

<b>Business Day</b>	: Any day when both the New York Stock Exchange and Luxembourg banks are open for business.
<b>Dealing Deadline</b>	: 4 pm U.S. Eastern Time.
<b>EPM</b>	: Efficient portfolio management.
<b>Investment Manager</b>	: AllianceBernstein L.P., a Delaware limited partnership.
<b>Management Company</b>	: AllianceBernstein (Luxembourg) S.à r.l.
<b>NAV</b>	: The value of the total assets of a portfolio less the total liabilities of such portfolio as described under the heading " <i>Determination of the Net Asset Value of Shares</i> " in the Prospectus.
<b>Offered Currency</b>	: Each currency in which the Shares are offered as described under the heading " <i>Classes of Shares</i> " in the Singapore Prospectus.
<b>Trade Date</b>	: The Business Day as of which any transaction in Shares (purchase, redemption or exchange) for the Portfolio is recorded in the shareholder register of the Fund as having been accepted.
<b>Valuation Date</b>	: The relevant Business Day on which the NAV of a class of Shares is determined.
<b>*</b>	: This Portfolio does not charge a redemption fee but note that certain classes of Shares are subject to a contingent deferred sales charge as further described in this product highlights sheet.
