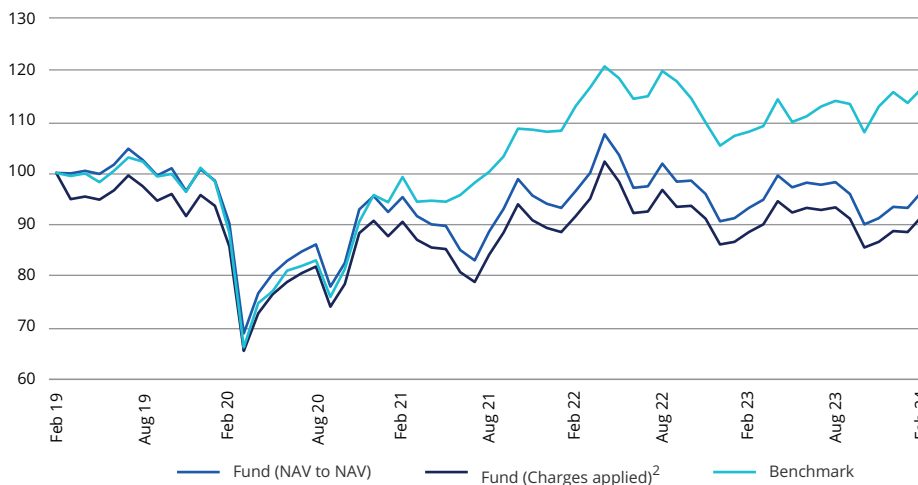
Objective
