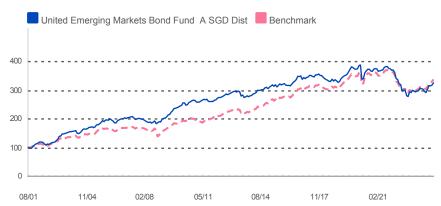


United Emerging Markets Bond Fund

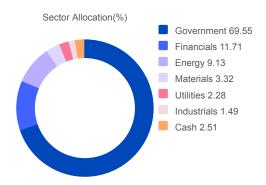
