PRODUCT SUITABILITY

WHO IS THE PRODUCT SUITABLE FOR?

- The Sub-Fund is only suitable for investors who:
 - o seek regular distributions and long-term growth; and
 - o are comfortable with the volatility and risks of a scheme which invests mainly in global equities, global fixed income and money market instruments.

KEY PRODUCT FEATURES

WHAT ARE YOU INVESTING IN?

- You are investing in a unit trust constituted in Singapore whose investment objective is to provide investors with regular distributions and long-term growth through investments in global equities, global fixed income and money market instruments.
- The current distribution policy is to make regular monthly distributions of 4% per annum (or such other frequency or percentage as the Managers may from time to time determine) of the NAV per Unit on the last Business Day of every calendar month or such other date as the Managers may from time to time determine (each a “Distribution Date”). Distributions will be made within 30 Business Days from the relevant Distribution Date.
The making of distributions is at the absolute discretion of the Managers and is not guaranteed.

Investment Strategy

- The Sub-Fund will primarily invest all or substantially all of its assets into the UGDBF Underlying Funds². The Sub-Fund may also invest in other collective investment schemes.
- The Sub-Fund will invest in approximately equal proportions between its equity asset allocation and fixed income asset allocation. For the purposes of tactical asset allocation, the Managers may deviate from either asset allocation by a 20% margin. The United Global Dividend Equity Fund will represent the equity asset allocation and the other UGDBF Underlying Funds represent the fixed income asset allocation. The Managers may invest into the UGDBF Underlying Funds which represent the fixed income asset allocation in such proportions at their discretion.
- The Sub-Fund may temporarily invest or hold its assets in money market instruments, liquid instruments or cash if at any time there are no suitable investment opportunities, as a defensive measure, or to safeguard the investment portfolio in times of extreme volatility in the markets. The Sub-Fund may hold its assets in liquid instruments or cash for liquidity purposes.

These can lead to sudden and large adjustments in such currency which can result in losses for the Sub-Fund. 	

- **You are exposed to political risk.**
 - Investments by the Sub-Fund may be adversely affected by political instability as well as exchange controls, changes in taxation, foreign investment policies, restrictions on repatriation and other restrictions and controls imposed by the relevant authorities in the relevant countries.
 - **You are exposed to derivatives risks.**
 - An investment in a FDI (including foreign exchange forward contracts and equity index future contracts) may require the deposit of an initial margin and additional deposit of margin on short notice if the market moves against the investment position. If the required margin is not provided in time, the investment may be liquidated at a loss. Therefore, it is essential that investments in FDIs are monitored closely. The Managers have controls for investments in FDIs and have in place systems to monitor the FDI positions of the Sub-Fund.
 - **You are exposed to risks relating to distributions.**
 - Dividend/interest income of the Sub-Fund may be adversely affected by (amongst others) investee entities suffering unexpected losses and/or paying lower than expected dividends. Distributions may also be made out of capital which may amount to a reduction of part of your original investment and may result in reduced future returns to you. Payment of distributions (whether out of capital or otherwise) may have the effect of lowering the Sub-Fund's NAV.
 - **You are exposed to concentration in the UGDBF Underlying Funds.**
 - The Sub-Fund may have a large concentration of investments in each UGDBF Underlying Fund and could consequently be subject to significant losses where any UGDBF Underlying Fund declines in value or is otherwise adversely affected. The Sub-Fund will be subject to different levels and combinations of risks based on its allocation among the UGDBF Underlying Funds and the potential impact that the losses and risks of an UGDBF Underlying Fund may have on the Sub-Fund would depend on the size of the Sub-Fund's allocation to it.

FEES AND CHARGES

WHAT ARE THE FEES AND CHARGES OF THIS INVESTMENT?

Payable directly by you

- You will need to pay the following fees and charges as a percentage of your gross investment amount:

Subscription fee	Cash and SRS: Currently up to 5%, maximum 5%.
Realisation charge	Currently 0%; maximum 2%.
Switching fee	Currently 1%; maximum 2%.

- You should check with the agent or distributor through whom you subscribe for Units whether they impose other fees and charges not disclosed in the Prospectus.

Payable by the Sub-Fund from invested proceeds

- The Sub-Fund will pay the following fees and charges from its assets to the Managers, Trustee and other parties:

VALUATIONS AND EXITING FROM THIS INVESTMENT

HOW OFTEN ARE VALUATIONS AVAILABLE?

Prices of Units will generally be published 2 Business Days after the relevant Dealing Day in local or foreign publications such as The Straits Times and The Business Times, and on the Managers' website at uobam.com.sg or any other website designated by the Managers. Prices may also be obtained from authorised agents and distributors of the Managers or by calling the Managers' hotline from 8 a.m. to 8 p.m. daily (Singapore time). To counter dilution and protect investors' interest, the Sub-Fund may apply a technique known as swing pricing as part of its valuation policy.

HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?

- You can exit the Sub-Fund on any Dealing Day by submitting a realisation form to the authorised agent or distributor of the Managers through whom you originally purchased Units. If applicable to you and you wish to exit the Sub-Fund within the cancellation period of 7 calendar days from the time of your subscription, you may do so by submitting a cancellation form and you will not incur the subscription fee and fees stated above. However, you will have to take the risk of any price changes in the NAV of the Sub-Fund since your subscription and pay any bank charges, administrative or other fee imposed by the relevant agent or distributor.
- The Managers may limit the total number of Units which holders of the Sub-Fund may realise and which the Managers are entitled to have cancelled on any Dealing Day to 10% of the total number of Units relating to the Sub-Fund then in issue.
- You will normally receive the realisation proceeds within 7 Business Days from the Dealing Day on which your realisation form is received and accepted.
- The realisation price of your Units is determined as follows:
 - If you submit the realisation form by 3 p.m. Singapore time on a Dealing Day, you will be paid a price based on the NAV of the Sub-Fund as at the Valuation Point of that Dealing Day.
 - If you submit the realisation form after 3 p.m. Singapore time on a Dealing Day or on a day not being a Dealing Day, you will be paid a price based on the NAV of the Sub-Fund as at the Valuation Point of the next Dealing Day.
- The net realisation proceeds that you will receive will be the realisation price of the Sub-Fund multiplied by the number of Units realised, less any charges. An example is as follows:

APPENDIX: GLOSSARY OF TERMS	
Business Day	A day (other than a Saturday, Sunday or gazetted public holiday) on which commercial banks are open for business in Singapore or any other day as the Managers and the Trustee may agree in writing.
Dealing Day	<p>In connection with the issuance, cancellation, switching, valuation and realisation of Units, generally every Business Day. The Managers may change the Dealing Days, provided that the Managers give reasonable notice of such change to all holders on terms approved by the Trustee.</p> <p>If on any day which would otherwise be a Dealing Day:</p> <p>(a) one or more recognised stock exchanges or over-the-counter markets or over-the-telephone markets on which investments of the Sub-Fund are quoted, listed or dealt in are not open for normal trading; and/or</p> <p>(b) one or more underlying entities of the Sub-Fund do not carry out valuation or dealing,</p> <p>and which affect investments of the Sub-Fund having in aggregate values amounting to at least 50% of the value of the assets of the Sub-Fund (as at the relevant Valuation Point), the Managers may determine that that day shall not be a Dealing Day.</p>
FDIs	Financial derivative instruments.
Launch Date	For the purposes of this Product Highlights Sheet only, means the inception date of the Sub-Fund.
NAV	Net asset value. NAV will be computed after taking into account any swing pricing adjustments (which may adjust NAV upwards or downwards in certain circumstances). Refer to the prospectus for details.
