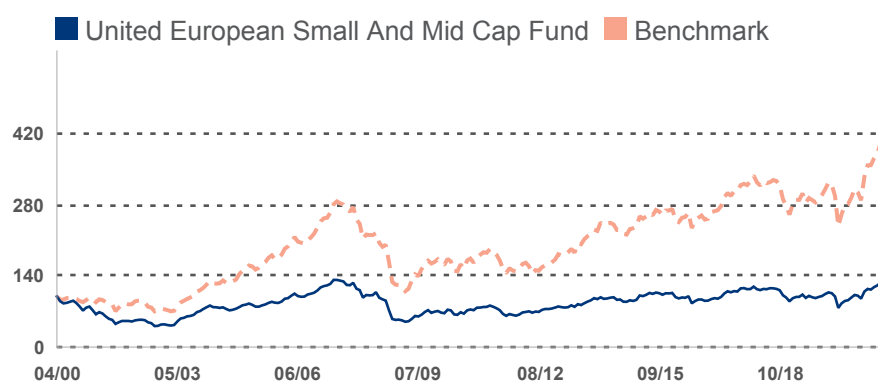


United European Small And Mid Cap Fund

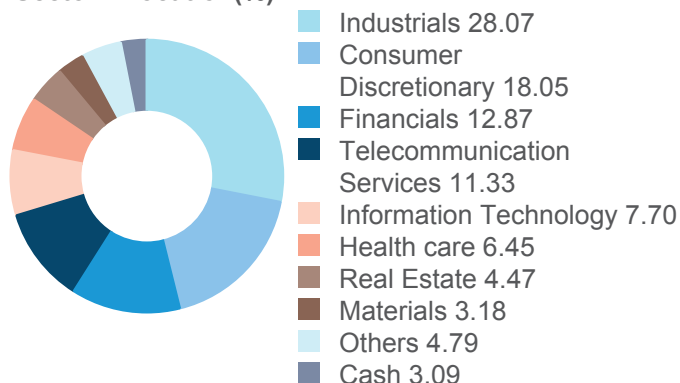

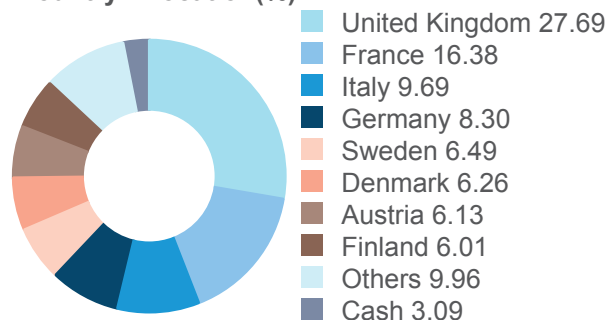
