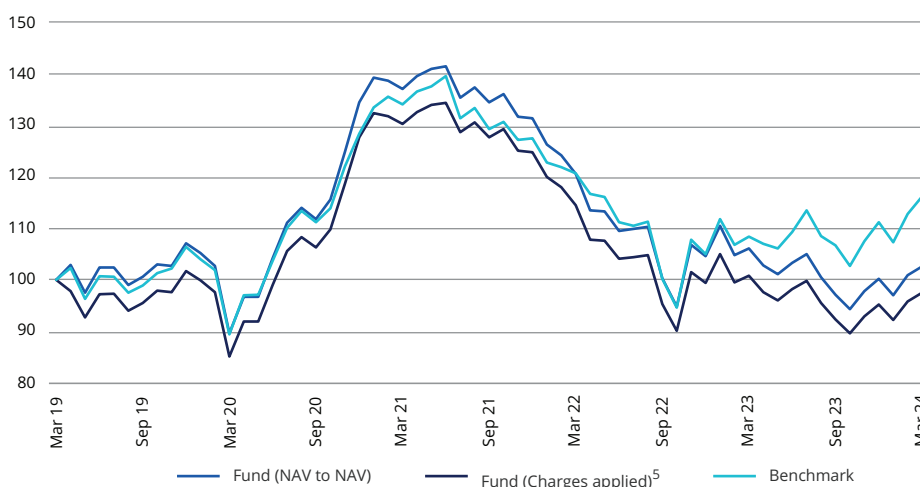
Objective

The Fund invests in equities and equity related securities of companies or institutions domiciled in, operating principally from, or deriving significant revenue from, Asia Pacific region excluding Japan.

The Fund aims to outperform the MSCI AC Asia Pacific ex Japan Index before charges.
