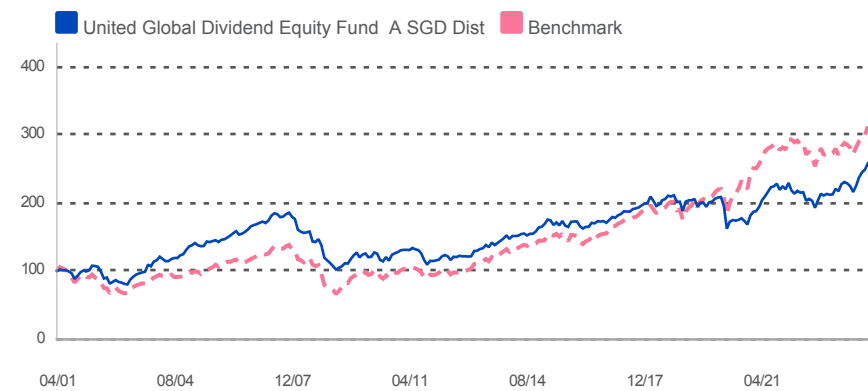


# United Global Dividend Equity Fund

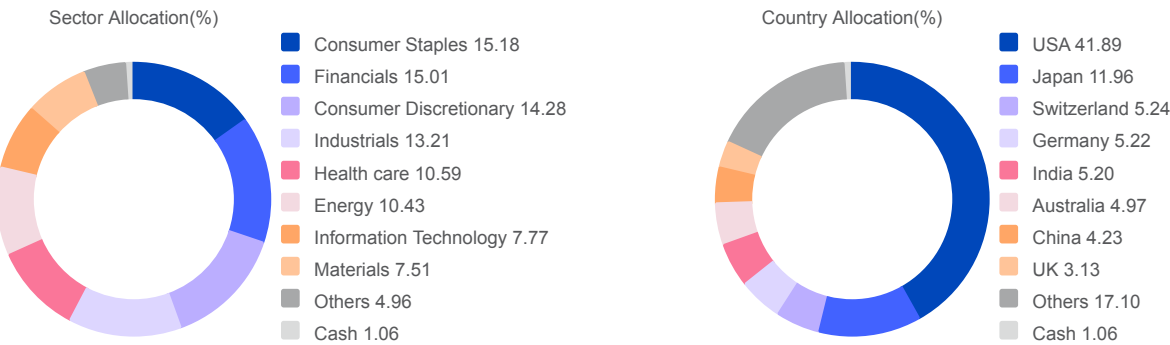
